FIRST AID MEASURES

PRECAUTIONS FOR SAFE HANDLING AND USE

HANDLE ACCORDING TO GOOD SAFETY PROCEDURES, AVOIDING UNNECESSARY EXPOSURE BY WEARING

APPROPRIATE PROTECTIVE GEAR FOR THE SITUATION. STORE IN FULLY CLOSED CONTAINERS IN A COOL DRY AREA AWAY FROM HEAT, LIGHT AND SOURCES OF IGNITION.
